#### **AMENDED ORDER OF JUDGMENT**

For the reasons stated on the record at a hearing on August 17, 2023 and in the court's memorandum opinion and order dated June 30, 2023, it is this 17<sup>th</sup> day of August 2023

**ORDERED** that **judgment** is hereby entered in favor of the plaintiff and against defendants Proud Boys International, L.L.C., Joseph R. Biggs, Jeremy Bertino, John Turano, Enrique Tarrio, and Ethan Nordean in the amount of \$1,036,626.78 plus costs and interest at the statutory rate from today's date. The defendants are jointly and severally liable for the judgment. It is further

ORDERED that for a period of five years from June 30, 2023, the date of the initial order of judgment, the defendants shall not: (1) come within 100 yards of Metropolitan African Methodist Episcopal Church, 1518 M Street NW, Washington, DC; (2) come within 100 yards of Reverend William H. Lamar IV; (3) contact Metropolitan African Methodist Episcopal Church or Rev. Lamar by any means; or (4) make any public statement in any forum, including on line, that is defamatory or threatening toward the church or Rev. Lamar or that would interfere with the church's or Rev. Lamar's religious activities. It is further

**ORDERED** that the amended complaint is dismissed without prejudice under Rule 4(m)(4) of the Superior Court Rules of Civil Procedure as to defendants John Does 1-8 and John Roes 1-15.

This is a final order within the meaning of Rules 54 and 58 of the Superior Court Rules of Civil Procedure.
